- Ascension Outreach
 - Ascension is conducting their own outreach campaign that includes our patients.
 - By Saturday, February 13th, all patients 75+ should have received an automated phone call, text message, and/or email with the links to schedule.
 - We are aware that the automated phone calls are being sent with our clinic phone numbers as the caller ID. This is causing a lot of patients to call our offices. Unfortunately there is nothing we can do to prevent this.

We are strongly encouraging everyone to utilize the online scheduling links for the Ascension sites to help patients secure an appointment. Many of our older patients are struggling with online appointment scheduling and we should assist them as we are able. Also, continue to encourage patients to check the links frequently, as availability changes nearly every day. DHS AND LABORATORY PARTNERS IDENTIFY SECOND CASE OF VARIANT STRAIN B.1.1.7 OF SARS-COV-2 IN WISCONSIN

On February 6, Wisconsin Department of Health Services (DHS) and laboratory partners identified a second case of variant strain B.1.1.7 of SARS-CoV-2 in Wisconsin. Please click here to read the full news release.

Of particular importance, the Wisconsin State Laboratory of Hygiene will perform whole genome sequencing to monitor the different strains circulating in Wisconsin. They are asking for the submission of the following types of samples for their surveillance efforts:

- Residual PCR positive samples from patients meeting the criteria below:
 - Traveled to another country within the previous 30 days
 - Known close contact with a person who tested positive for COVID-19 after traveling to another country in the previous 30 days.
 - Prolonged clinical illnesses, including those who are suspected of having protracted SARS-CoV-2 viral replication, are immunocompromised, or who have a recurrence of COVID-19 disease after an initial period of recovery.
 - Suspected repeat infection occurring in patients who received monoclonal antibody therapy, convalescent plasma therapy, or antiviral drugs including remdesivir.
 - Anv SARS-CoV-2 infection in an individual who has received a COVID-19 vaccine
