MMA COVID VACCINE CLINIC UPDATE

By the end of last week, Madison Medical had administered 324 first doses of the Moderna COVID-19 Vaccine. Thank you to everyone who helped make that initial rollout a success. After many lessons learned, we have decided that a dedicated home for our vaccine clinic is needed. Beginning Monday, January 18th, we will be conducting a vaccine clinic 5 days per week at our Madison Medical Jefferson office on the 1st Floor. We will start by vaccinating up to 300 first doses of the Moderna COVID-19 Vaccine per week. Here is who eligible to receive a vaccine through us:

- All MMA Employees
- All Phase 1A Individuals regardless of affiliation
- Phase 1B Police & Firefighters ONLY

The ability to schedule an appointment will be via invite only. To add yourself to the invite list OR to refer an eligible individual to our vaccine clinic, please complete <u>this form</u>.

COVID-19 HEALTH ALERT FROM WDHS: SURVEILLANCE FOR NEW GENETIC VARIANTS

New variant strains of SARS-CoV-2 have been recently described in numerous countries, and are believed to be more highly transmissible than wild-type SARS-CoV-2. Several infections with this strain have been detected in Canada and the United States, but it is not currently known how widely the variant is circulating in North America. Additional "variants of concern" will likely be identified in the coming months and will warrant ongoing surveillance.

In Wisconsin, several clinical, research and public health laboratories are actively participating in genomic surveillance for novel and emerging strains, in collaboration with DHS and CDC. Clinicians can support this work by notifying DHS of any cases of COVID-19 that are travel-associated, or that occur in patients who previously received antiviral treatment, antibody-based treatment, or vaccination for COVID-19. COVID-19 VACCINE UPDATE - PFIZER


As many of you are aware by now, the FDA has granted an Emergency Use Authorization for the Pfizer-BioNTech COVID-19 Vaccine. Here are some general resources for the vaccine:

Per the Advisory Committee on Immunization Practices (ACIP), health care workers and residents of long term care facilities are the first priority group (Phase 1A) to receive the vaccine. Given limited quantities of the vaccine at this time, further prioritization within these categories are required. Generally speaking, our counterparts at the hospitals are the first priority. Once that population has been vaccinated, the clinics will be next in line.

Madison Medical Affiliates has signed-up to be a Phase 1A vaccinator. At this time, we do not $k \odot 1$ when we will receive our first shipment of vaccines. In the interim, we are hard at work

CDC RELEASES OPTIONS TO REDUCE QUARANTINE FOR CONTACTS

The CDC has released Options to Reduce Quarantine for Contacts. Please be aware of the published options, but duration of quarantine remains a local public health decision. Wisconsin DHS has not yet made a response.

Current CDC Options:

- CDC currently recommends a quarantine period of 14 days.
- Quarantine can end after Day 10 without testing and if no symptoms have been reported during daily monitoring. With this strategy, residual post-quarantine transmission risk is estimated to be about 1% with an upper limit of about 10%.
- When diagnostic testing resources are sufficient and available, then quarantine can end after Day 7 if a diagnostic specimen tests negative and if no symptoms were reported during daily monitoring. The specimen may be collected and tested within 48 hours before the time of planned quarantine discontinuation (e.g., in anticipation of testing delays), but quarantine cannot be discontinued earlier than after Day 7. With this strategy, the residual post-quarantine transmission risk is estimated to be about 5% with an upper limit of about 12%.
